TYPHOON ANNOUNCES THE CONCLUSION OF A 2D STUDY WITH DIAGNOS

Laval, Canada, February 11th, 2010 – **Typhoon Exploration Inc announces** the results from a study carried out by the DIAGNOS INC. team, which utilized CARDS prediction system.

On a regional scale (figure 1) CARDS new prediction methods - "C-Cluster" and "Ageo" - developed by the DIAGNOS team, revealed the presence of a major anomaly located 700 meters east of the Mc Donald showing which potentially corresponds to a porphyry-type gold mineralization. This anomaly lies north of a high-probability GOCAD zone. Drillings were completed by Minerai Lac in 1997 (AIG-97-08, AIG-97-14 and AIG-97-15) south of the DIAGNOS anomaly. These auriferous drillings obtained values of 441 ppb on 8.63 meters (AIG-97-08) and 1698 ppb on 3.25 meters (AIG-97-15). The core of the AIG-97-14 drill hole has been re-verified and re-analysed by Typhoon Exploration's team. The principal lithology towards the end of the survey is that of a hematized, albitized porphyric intrusion containing a stockwerk network of quartz veins. The intrusion is mineralized by fine cubic pyrite with traces of chalcopyrite. A large section of 33 meters which had not yet been analyzed was sawed out and sent for assay. The results obtained were clearly anomalous with gold values ranging from 100 to 300 ppb.

Due to its proximity to a Gocad target, the DIAGNOS anomaly opens a new potential exploration area at more than 700 meters east of the Mc Donald Showing and 1000 meters east of the Fayolle Deposit. Drillings carried out in proximity to this anomaly confirm the presence of gold and the pertinence of the technical approach developed by Typhoon Exploration's team.

Mr. Robert Gagnon, P. Geo., Technical Advisor, a Qualified Person as defined by National Instrument 43-101, supervised the preparation of the information in this news release.
